

**CORRIGENDUM TO ANNOUNCEMENT IN RELATION TO APPLICATION FOR AN
EXTENSION OF TIME TO COMPLY WITH RULES 707(1), 707(2), 711A AND 705(2)(d) OF THE
SINGAPORE EXCHANGE SECURITIES TRADING LIMITED (THE “SGX-ST”) LISTING
MANUAL (SECTION B: RULES OF CATALIST) (THE “CATALIST RULES”)**

The Board of Directors (the “**Board**”) of Net Pacific Financial Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to its announcement dated 7 October 2025 titled “APPLICATION FOR AN EXTENSION OF TIME TO COMPLY WITH RULES 707(1), 707(2), 711A AND 705(2)(d) OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED (THE “SGX-ST”) LISTING MANUAL (SECTION B: RULES OF CATALIST) (THE “CATALIST RULES”)” (the “**Previous Announcement**”).

(a) *Goodwill impairment assessment*

*The Company had on 10 May 2025 ~~2024~~ announced the completion of the acquisition of 51% of the total issued and paid-up share capital of Saint Pearl Travel Products (Guangdong) Co., Ltd (“**Saint Pearl**”) to diversify and engage in the research, design, production and sale of travel hard cases in the People’s Republic of China (“**Luggage Business**”) (“**Acquisition**”).*

Save as disclosed above, all the information in the Previous Announcement remains unchanged.
