Consequently, Zhou Dan directly holds 120,000,000 shares and Ben Lee will be deemed interested in these 120,000,000 shares held by Zhou Dan.

Full Join Holdings Limited has also entered into separate sale and purchase agreements with other persons and will cease to hold shares in the Company upon completion of these sale and purchase agreements. Consequently, deemed interests pertaining to Full Join Holdings Limited would no longer be applicable in relation to Ben Lee.
